PRIVACY POLICY

OVERVIEW

GS Operating, LLC dba Gexpro Services ("Gexpro Services" or "Company") knows that you care how information about you is used and shared and we appreciate your trust that we will do so carefully and sensibly. This Privacy Policy covers information collected by us, or provided to us, on various media, including www.gexproservices.com, our LinkedInTM page or other social media sites, any related mobile websites, advertisements, and applications (collectively, the "Site"), and information we receive over email or telephone, or by our sales representatives (collectively, "Customer Service"). This Privacy Policy also covers information that we may receive from other persons or companies who have received your information and can share it with us. By visiting the Site or communicating with Customer Service, you are accepting the practices described in this Privacy Policy.

TYPES OF INFORMATION WE COLLECT

Our intention is to limit our personal information/personal data collection to only what is needed to perform our obligations and effectively run our Company. The quantity and scope of that information varies by the type of work being undertaken. Accordingly, personal information/personal data collected or received may include but not be limited to:

- General identification and contact information, such as your name, address, e-mail, and telephone number.
- In the course of processing job applications, we receive identification numbers issued by federal or state governments, including, but not limited to, Social Security number and driver's license number, and sometimes we also receive this information in the course of rendering services to our clients.
- Any information you provide us via correspondence, including but not limited to e-mail, voicemail, and recordings of telephone calls to our staff and offices.
- For clients receiving our services, we receive payment information.
- Pursuant to rendering certain services to our clients, we may occasionally receive information about an individual's current or former physical, mental, or medical condition, health status, injury or disability, or medications consumed.
- Information from our subsidiaries including assignment information.
- Information from our clients regarding assignments we undertake for them and through which the personal information is provided for our use in rendering services.
- Technical information from website visitors, including internet protocol (IP) address, login information (username/password), browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access our website.

Some of the information we collect about you may be personal information, or personal data, that can be used to identify you including, for example, your name, email address, mailing address or delivery address. In some jurisdictions, certain unique identifiers like IP addresses and other usage or technical information may be considered personal information. Personal information does not

include data where your identity has been removed so that we can no longer identify you (anonymous data or aggregated data), which we may use for any purpose.

HOW WE COLLECT YOUR INFORMATION

Information You Manually Provide: Gexpro Services collects information, including personal information, that you knowingly and manually provide when you use our Site or Customer Service. For example:

- If you use a "contact us" form to ask us a question, we will collect whatever personal information you submit with or include in your question.
- If you order products through our Site or Customer Service, we will ask you to provide the information we need to process and ship your order, such as your email address, billing and shipping address and perhaps your credit card information.

The type of personal information we collect varies depending upon how you contact us and how you use our Site and Customer Service.

Information Sent to Us by Your Web Browser: We collect information that is sent to us automatically by your web browser. This information typically includes your IP address, the identity of your Internet service provider, the name and version of your operating system, the name and version of your browser, the date and time of your visit, and the pages on our Site that you visit. Please check your browser if you want to learn what information your browser sends or how to change your settings. Your IP address is the identifier assigned to your particular computer when you access the Internet. IP addresses do not include your name, email address or other personal information, but in some cases, they can be used to identify you. For example, if you have registered with our Site, we may link your IP address to account information that identifies you personally. We may also use IP addresses in connection with other information gathered elsewhere in an attempt learn the identities or general geographic locations of people who visit our Site. If we suspect inappropriate or criminal activity or a threat to our Site or its users, we may share our server logs—which contain users' IP addresses—with the appropriate investigative authorities, who could use that information to trace and identify individuals. We do not respond to or honor "do not track" (a/k/a DNT) signals or similar mechanisms transmitted by web browsers.

Cookies and Similar Technologies: Most websites use cookies and/or similar technologies to place information about a user's visit to that website in a small data text file that is stored on the user's computer. In general, we use cookies and other web technologies to:

- Collect information about the ways visitors use our Site—which pages they visit, which links they use, and how long they stay on each page;
- Support the features and functionality of our Site-for example, to save you the trouble of reentering information already in our database or to prompt the settings you established on previous visits; and
- Personalize your experience when you use our Site, including by serving targeted advertisements.

Generally, the information we collect using these web technologies does not identify you personally. If, however, you have created a user account, we may link the information we collect using these web technologies to other information that identifies you personally. If you do not wish to receive cookies, you may be able to set the browser of your computer to reject cookies or to alert you when a cookie is delivered. You may also be able to delete our cookies as soon as you leave our Site. Although you are not required to accept our cookies when you visit our Site, if you set your browser to reject cookies, you may not be able to use all of the features and functionality of our Site.

Plugins: The Site may make available the option for you to use "plugins" that are operated by other companies. If you choose to use one of these plugins, then it may collect information about you and send it back to the company that owns it. This may happen even if you do not click on the plugin, if you are logged into the social media website that owns the plugin when you visit the Site. Information collected by a plugin is subject to the privacy policy and terms of the company that makes it. If you do not want the company who owns a plugin to collect information about you when you visit the Site, sign out of the company's website before visiting. By interacting with a plugin when you are on the Site (for example, clicking the Facebook_{TM} "Like" button), you are intentionally transferring information to that company. Further, if you are logged into a company's website when you visit the Site, then you are directing us to share your data with the company that owns the plugin.

Web Beacons: Our website pages, advertisements, and e-mails may contain small transparent embedded images or objects known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit us, for example, to count website page visitors or email readers, or to compile other similar statistics such as recording website content popularity or verifying system and server integrity.

Information from your mobile device: If you access our Site through your mobile device, we may automatically collect certain information from or about your mobile device. The types of information we may collect include the type of device you use, your device's unique ID, the IP address of your device, your device's operating system, the type of mobile Internet browsers you use, and information about the way you use our mobile website. If you have questions about the security and privacy settings of your mobile device, please refer to instructions from your mobile service provider or the manufacturer of your device.

Information Collected by Third-Party Cookies: In addition to the cookies Gexpro Services delivers to your computer through our Site, certain third parties may deliver cookies to you for a variety of reasons. You have choices about the collection of information by third parties on our Site. We may use the LinkedInTM Insight Tag to collect data on conversion tracking or other metrics. We do not receive personal information from LinkedInTM, but we cannot control all the ways LinkedInTM may use and collect your data. More information about the LinkedInTM privacy practices may be found in the <u>LinkedInTM Privacy Policy</u>, <u>LinkedInTM Advertising Preferences</u>, and the <u>LinkedInTM Opt Out Page</u>. - Protect our Site and ourselves legally;
- Enforce terms and conditions and policies;
- Respond to legal requests and prevent harm;
- Provide security, credit or fraud prevention; and

the rights or property of our clients; or (c) in an emergency to protect the personal safety of our employees, clients, visitors or the public. Gexpro Services may also disclose information to its accountants, auditors, agents, lawyers and other advisors in connection with the enforcement or protection of our legal rights or to protect the interests or safety of our customer, our customers' customers or employees or others, in accordance with or as authorized by law.

Use of Aggregated Information: We may use information gathered through our Site and Customer Service to create a compiled, aggregate view of our visitors and their usage patterns. We use aggregated information to operate our services and to better understand our visitors as we develop new products and services. We may also share aggregated information with our third-party service providers as well as with other third parties so they can better understand the market we serve. Aggregate information does not constitute personal information.

Steps We Take to Safeguard your Personal Information: We maintain reasonable administrative, physical and technological measures to protect the confidentiality and security of personal information you submit on or through our Site or through Customer Service. Unfortunately, no website, server, or database is completely secure or "hacker proof." We therefore cannot guarantee that your personal information will not be disclosed, misused or lost by accident or by the unauthorized acts of others.

Data Retention: Your personal information may be kept in other countries, such as the United States, and accessible to our employees and service providers who have a "need to know" such information for the purposes described in this privacy policy. Except as otherwise permitted or required by applicable law or regulation, we will only retain your personal information for as long as necessary to fulfill the purposes for which we collected it, and/or for the purposes of satisfying any legal, accounting, or reporting requirements. Under some circumstances we may anonymize your personal information so that it can no longer be associated with you, either directly or indirectly, alone or in combination with any other information. We reserve the right to use such anonymous and de-identified data for any legitimate business purpose without further notice to you or your consent.

Accessing and correcting your personal information: By law you have the right to request access to and to correct or rectify the personal information that we hold about you, subject to certain exceptions as required or permitted by applicable law. If you have any account, you can review and change your personal information by logging into your account and visiting the pages that correspond to the information you want to review and change. In some cases, a change of information may require a new account. If you want to access, review, verify, correct, rectify, update, or withdraw consent to the collection, use or disclosure of your personal information you may also contact us as directed in the Contact Us section of this policy to make such a request. We may not accommodate a request to change information if we believe the change would violate any law or legal requirement or cause the information to be incorrect. We may request specific information from you to help us confirm your identity and your right to access, and to provide you with the personal information that we hold about you or make your requested changes. Applicable law may allow or require us to refuse to provide you with access to all of some of the personal information that we hold about you, or we may have destroyed, erased, or made your personal information anonymous in accordance with our record retention obligations and practices. If we cannot provide you with access to your personal information, we will inform you of the reasons, subject to any legal or regulatory restrictions.

We will provide access to your personal information, subject to exceptions set out in applicable privacy legislation. YOUR EU/EEA/UK PRIVACY RIGHTS

Additional information about data we collect about you: Although we do not intend to collect any special categories of personal data about you (including details about your race, ethnicity, religious or philosophical opinions, trade union membership, information about your health, genetic data, biometric data, or criminal conviction and criminal offense data) it is possible that our clients may share such information with us as a result of a specific assignment that our clients provide to us.

Lawful basis: We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we need to perform the contract, we are about to enter into, or have entered into with you.
- Where it is necessary for our legitimate interests (or those of a third party) and your
 interests and fundamental rights do not override those interests, potentially including
 uses such as determining the success of our services and for determining marketing
 performance to share relevant information and offers about our products with clients
 and potential clients.
- Where we need to comply with a legal obligation.

Generally, we do not rely on consent as a legal basis for processing your personal data although we will get your consent before sending third party direct marketing communications to you. You have the right to withdraw consent to marketing at any time by contacting us.

do not use any type of automated process for profiling purposes.

Data retention: We will only retain your personal data for as long as reasonably necessary to fulfill the purposes we collected it for, including for the purposes of satisfying any legal, regulatory, tax, accounting or reporting requirements. We may retain your personal data for a longer period in the event of a complaint or if we reasonably believe there is a prospect of litigation in respect to our relationship with you.

To determine the appropriate retention period for personal information, we consider the amount, nature and sensitivity of the personal data, the potential risk of harm from unauthorized use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal, regulatory, tax, accounting or other requirements. In any event, we do not intend to hold the data for more than five years.

Transfer of Data: Your personal data may be transferred to, and maintained on, computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction. If you are located in the EU, EEA, or UK and choose to provide information to us, please note that we may transfer the data, including personal information, to other countries outside of your region and process it there. Your consent to this privacy notice followed by your submission of such information represents your agreement to that transfer.
